**Election of District Cricket Association (DCA) Khanewal** 

In continuation of, Election Commissioner PCB letter dated 1<sup>st</sup> June 2023, whereby, Election of DCA Khanewal to the extent of Polling was postponed, pursuant to the Court order dated 31<sup>st</sup> May 2023, passed by the Learned Civil Judge 1<sup>st</sup> Class Khanewal in a Civil Suit titled "Shaheen Cricket Club Vs PCB etc.". The above-mentioned suit has been dismissed vide order dated 26<sup>th</sup> July 2023, therefore, the election process of DCA Khanewal is to be resumed.

2. The final list of candidates was issued on 30<sup>th</sup> May 2023 by, the then, Deputy Election Commissioner PCB, whereby, Mr. Mohsin Ashraf was the only candidate for the seat of President and the appeal filed by Mr. Awais Mehmood, rival candidate for the seat of President, before PCB Board of Governors titled "Awais Mehmood Vs Election Commissioner PCB etc., has also been decided/dismissed by the Honorable Independent Adjudicator of PCB vide judgment dated 15<sup>th</sup> November 2023.

3. One of the contesting candidate for the seat of Secretary DCA Khanewal named Mr. Naveed Ahmed has passed away on 20<sup>th</sup> November 2023 and his death certificate has been received in this office. Therefore, to provide a fair opportunity to the voters to elect their



representative for the seat of Secretary DCA Khanewal, it is required that fresh nomination forms for the seat of Secretary DCA Khanewal be invited from other interested candidate(s).

- 4. In view of the above, a revised election schedule for inviting the nomination forms, only for the seat of Secretary DCA Khanewal, as well as, polling for the seats of Secretary & Treasurer DCA Khanewal is being issued. Mr. Allah Rakha, who has earlier filed nomination form for the seat of Secretary DCA Khanewal, which has been accepted, needs not to file nomination form afresh.
- 5. Now, the election for the seats of Secretary & Treasurer DCA Khanewal will be held as per attached schedule:-
